- The Renter agrees to use the equipment in a good and careful manner, maintain its appearance and condition, and comply with all relevant laws respecting the use of equipment (Including, but not limited to, environmental and copyright laws). While normal wear & tear is expected, Renter will owe GLRR the Cost of Replacement if items are lost or damaged beyond repair.
- The Renter will use the equipment for the intended purposes of staging and operating a road race (or a similar, relevant purpose, as agreed to by the undersigned GLRR officer). If Renter does not comply with this requirement, they shall owe funds to GLRR as reasonably determined by the undersigned officer.
- Unless prior written consent is obtained by the undersigned GLRR officer, the Renter will not alter, modify or attach anything to the equipment unless the alteration, modification or attachment is 1) easily removable and 2) does not damage the functional capabilities or value of the equipment.
- Rental cost of equipment may be reduced or waived in exchange for volunteer hours at a GLRR sponsored event if prior agreement is made with designated officer of GLRR (Vice President)
